## 1.- Organiser of the draws

### 4.-Participation requirements:

  - 2. Like the publication of the sweepstakes in which you want to participate.
    - 3. Tag at least 1 person in the comments.

\*Followers can participate as many times as they want, as long as they meet the requirements. \*Participation in one prize draw does not prevent participation in the others.







# > TO THE DRAW FOR THE VIP WEEKEND AT PLATJA D'ARO:

- 1. Be of legal age
- 2. Make a purchase or consumption in a participating establishment, for a value equal to or greater than €20.
- 3. For each purchase or consumption ticket you will receive a participation ticket.

## HOW TO PARTICIPATE:

- 1.- Fill in the ticket with your personal details.
- 2.- Deposit it in the mailbox of the establishment.
- 3.- Keep the receipt and ticket/invoice of purchase together.

\* Each customer can participate as many times as they wish according to the number of tickets, they obtain with a consumption of 20€ or more, as long as they keep the receipt and the ticket.

They are excluded from participating in the draws:

The staff of companies supplying products or services to the organising entity (AdEM).

• Staff and owners for purchases/consumption made in the establishment itself. All may participate by making purchases/consumption in other establishments.

## 5.- Selection of the winners, communication and prize-giving.

Each draw will be carried out, on the scheduled dates, as indicated below:

## > Via Instagram:

- By means of automatic draws via Instagram APP, which will be recorded in an internal video, as transparent proof of the choice of the winner in a legal manner.
- For each draw there will be one winner and 2 alternates.
- The choice of the winner will be announced in a post on our Instagram profile, the same day or the following day, after verification of compliance with the conditions and rules of the draw.
- AdEM will contact the winner of the draw via private message on Instagram.
- The winner must contact AdEM within 6 days of the date on which the message was sent. If at the end of the established period, we have not received a response, we will contact the first alternate, to whom the same deadlines as those indicated by the winner will apply, and if necessary, the second alternate will be contacted. Once the substitutes have been exhausted, AdEM reserves the right to declare the draw void.

### > By purchase/consumption with a ticket and ballot box in participating establishments.

- By means of a draw among all the tickets, in the Assembly Hall of the Castell d'Aro, Platja d'Aro and S'Agaró Town Council, on 10 July at 12 noon, open to the public and in the presence of the competent authorities. A second ticket will be drawn if the first one does not meet the participation requirements.

- The winner will be contacted by the AdEM via e-mail and/or telephone. If the winner is notified by e-mail, he/she must contact the AdEM within 5 days from the date of receipt of the e-mail. If, at the end of the established period, no contact is made, the first substitute will be contacted and the same deadlines will apply. If there is no response, AdEM reserves the right to declare the draw void.

The prizes will be delivered in person, with a visual report for publication in XXSS and/or other media, on the dates indicated to the winners and must be collected by the winner, or the person designated by the winner, identifying themselves with their ID card, passport or accrediting document that AdEM considers equivalent.







### PRIZES FOR COLLABORATING ESTABLISHMENTS AND PERSONNEL INVOLVED:

1 ticket will be drawn for each of the 3 prizes:

- 1st prize for the collaborating partner: A place on a helicopter flight over the Costa Brava for one of the member establishments.
- 2nd prize for the staff involved: A stay in a BCN hotel with breakfast, dinner for 2 people and more.

The 2nd and 3rd prizes will be drawn among the staff of the winning establishments and will be published on XXSS. If the tickets from the same establishment coincide, a second ticket will be drawn.

# 6.- Dissociation from Instagram
